OLD BUSINESS

LEPC Information Cards, Trifolds or Singular Page

Ms. Mason gave a break down in costs for the trifolds and information cards. The LEPC card would be 3.6” x 11” 2-sided document on cardstock with full color. The cost for 18,000 would be \$1783.32. The LEPC trifold would be printed on 8.5” x 11” paper double sided in full color. The cost for 18,000 is \$3164.40. The LEPC 1 page flyer would be printed on 8.5” x 11” paper with full color. The cost for 18,000 would be \$1,400.40 for 1 sided and \$2,300.40 for 2 sided.

Mr. Larmore asked for an example of the trifold before the committee would take their recommendation to the IERC for voting. Ms. Mason and David Hosick agreed to this.

NEW BUSINESS

EPA Risk Management Program (RMP) Amendments

Mr. Larmore asked IDHS staff if the EPA had mentioned the new Risk Management Program Amendments at the National Association of SARA Title Three Program Officials. Ms. Roe addressed his question by stating the EPA did give a presentation on the amendments and the lawsuit surrounding them. She stated the EPA would have something out by the end of the year summarizing these, but that the dates given in the amendments still stands. Mr. Larmore stated Marion County’s LEPC were trying to be proactive to these changes by having language and a process to deal with the twenty-two RMP facilities in their county and would like to see other counties doing the same. Staff said they would be sending out information on these amendments and how LEPCs should address RMP facilities coming to them. This information will also be included in the links on the IERC newsletter.
