7. **Proposal – Allow copy of 2007 ASME A17.1 in Testing Area for Indiana Elevator Mechanic Exam** – No written public comment was submitted to the Commission by the due date save for Mr. Selke’s explanation. Mr. Selke and Mr. Watson presented, noting that many jurisdictions allow for completely open book testing, as opposed to asking for one of the manuals. Mr. Pannicke suggested clarifying what condition the book must be in to disallow additional information (margin notes, highlighting, anything that might give the tester an advantage). Commissioner Cook expressed concern that there was little information on which questions were being missed more. Bart Giesler expressed concern that the test isn’t the issue, but the education of the test takers. Kevin Chalmers suggested reviewing open book test standards. Mr. Cook abstains.
