SUBJ: DWD Commissioner's Directive 2004-43  
To extend DWD Communications and Policies concerning WIA beyond June 30, 2005

**Purpose**

To list those DWD Communications and Policies regarding the Workforce Investment Act (WIA) that will remain in effect beyond their current expiration dates pending the reauthorization of the Act.

**Content**

Attached is a list of the DWD Communications and Policies concerning the Workforce Investment Act, which were scheduled to end on June 30, 2005, according to DWD Commissioner's Directive 2004-02. Although the Workforce Investment Act (WIA) of 1998 law was originally funded from 1999 through 2003, it has been continued since that date by Congressional Resolution rather than formal reauthorization. Congress has continued to discuss reauthorization, but to date no new law has been passed. Therefore, the policies in the attached list will remain in effect until June 30, 2006, or until rescinded or revised. Upon the reauthorization of the Act, these policies will be reviewed and updated based on the new legislation.
